6. Worcestershire County Council - Access Road U41552 (off The Holloway), Droitwich. Proposed Revocation Of Prohibition Of Waiting At Any Time Order (Initial Consultation) *[plan attached]*

The County Council has recently reviewed the order prohibiting parking on access road U41552 (off The Holloway) Droitwich, following it having been identified that a greater extent of it was part of the publicly maintainable highway than previously thought. The extent of the prohibition goes further than is required to ensure access for emergency vehicles, which was the purpose of the order. In consequence, it is considered to interfere with on-street parking to an unnecessary degree. Accordingly, it is proposed to make a further traffic order reducing the prohibition to exclude the frontage of the garage on the north side of the access road, please see drawing 2013.462.2 for further details. Comments have been requested by 10 December 2014.

7. Worcestershire County Council – Tagwell Road, Droitwich. Proposed Limited Waiting 1 Hour, No Return 2 Hours 8am – 6pm Order (Initial Consultation)

The County Council has issued the attached drawings showing a proposal to introduce a section of Limited Waiting in Tagwell Road thereby creating more on street parking to facilitate turnover and assist local businesses. It has the support of the local member County Councillor Mrs Pam Davey. Comments have been requested by 19 December 2014.
