7. South Worcestershire Development Plan – Consultation:
On 30 September 2014 the three South Worcestershire Councils considered a range of proposals in response to the interim conclusions of the Inspector which suggest that 28,400 homes will be now need to be provided in South Worcestershire by 2030 instead of the 23,200 originally proposed.
