The area in question concerns the footpath that is the continuation of Westlands Walk (ie at the rear of 11 - 19 East Park Drive). The Extinguishment Order is to enable the replacement of a retaining wall which is in a dangerous condition and refers only to part of the width of the footpath DW-569 (formerly Footpath No 31).*
