5. Decisions of the Local Planning Authority:-
  - a Approval Notices: Wychavon District Council, the Local Planning Authority, has issued 4 approval notices, all of which did accord with the recommendations of the Town Council.
  - b Refusal Notices: No refusal notices have been issued.

6. Notification of Planning Appeal :-  
Wychavon District Council have advised on 28 November 2018 that planning application reference 18/000878 FUL has been lodged as an appeal with the Planning Inspectorate. The appeal start date is 27 November 2018 and the original proposal is change of use of the land and erection of one single storey dwelling. The site is land adjacent Clover Patch, 7 Pridzor Road, Droitwich Spa. This application was originally considered by Droitwich Spa Town Council Planning Committee on 2 July 2018 and a consultation response of “no objection” was submitted the following morning. All Planning Inspectorate correspondence is available to view on the usual online Wychavon Planning portal under the application reference. *[details attached for information]*
  
7. Worcestershire County Council- Proposal to introduce “Prohibition of Waiting at Any Times” restrictions. The location is both sides of Netherwich Gardens, Droitwich Spa around the junction with Honeymans Gardens. This proposal is a result of complaints received by WCC Highways from local residents regarding obstructive parking at the road junction. The implementation of double yellow lines at this junction would prevent such parking, thereby aiding visibility for turning vehicles. The support of the local County Council Ward Member – Councillor Richard Morris has also been confirmed *[details attached for information]*
  
8. Worcestershire County Council– Road Traffic Regulation Act 1984, Section 14 (as amended). Notice of Closure of Footpath F40026 Thatchers Green, Droitwich Spa as an emergency measure. Footpath F40026 will be closed from its junction with F40058 Ploughmans Rise for a distance of 53 metres in a north easterly direction. The order provision is up to 5 days from the 21 November 2018 and work is anticipated to last 3 days for essential gas main repairs. *[details attached for information]*
  
9. Worcestershire County Council- Road Traffic Regulation Act 1984, Section 84 (as amended). Draft Order for revocations and proposals for 30 mph and 40 mph speed limits on various roads in Droitwich Spa, Hampton Lovett and Cutnall Green. The public notice has recently been issued to the local press for information. *[details attached for information]*.
