6. Notification of Planning Appeal. On 30 June 2022 Wychavon District Council notified that Planning application reference 20/00183/OUT for the proposed development of up to 100 new dwellings at the location described as “Field off Tagwell Road, Droitwich Spa” is subject to an appeal lodged with the Planning Inspectorate. The Notification letter is attached and any representations must be received by the Planning Inspectorate by 2 August 2022 *[for information]*.
 7. Notification of Planning Appeal. On 7 July 2022 Wychavon District Council notified that Planning application reference 21/02854/FUL for the proposed erection of 1 no. detached dwelling, 2 Spa Road, Droitwich Spa, WR9 8RG is subject to an appeal lodged with the Planning Inspectorate. The notification is attached and any representations must be received by the Planning Inspectorate by 10 August 2022 *[for information]*.
 8. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). First Notice of Road Closure and temporary traffic restrictions for B4090 Worcester Road, Droitwich Spa. The section affected is between the junctions of U41543 St Andrews Road and B4090 Salt Way. The closure is to enable carriageway resurfacing works and provision has been made for 12 days commencing 8th August 2022 *[public notice and location maps attached for information]*
 9. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). C2086 Pulley Lane & Newland Lane 40 MPH speed limit order. To implement the revised speed limit from the junction with the A38 Worcester/Droitwich Road to the junction with C2076 Tagwell Road in its entirety. Any representations to be sent to Worcestershire County Council – Traffic regulations by 10 August 2022. *[Notice and location map attached for information]*.
 10. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). Second Notice of Order for Road Closure and temporary traffic restrictions for U41544 St Andrews Road, Droitwich Spa. To close the section from the junction with U41531 Friar Street to the junction with U41539 Victoria Square to enable cable ducting blockages to be removed by Contractors – Full Fibre. Anticipated duration is two nights of working (18.00 to 23.30) from 20 July 2022 *[Notice and location map attached for information]*.
