4. Droitwich Spa Charter Market – Pursuant to Minute Number 109 of the Community & Amenities Committee meeting held on 11 September 2017 and minute number 160 of the meeting held on 13 November 2017 the Assistant Town Clerk has recently initiated further contact with Mr Joe Jones from 'One To One Events'. An agreement was made with Mr Jones in December 2017 to revisit his tentative proposal to consider a relaunch of the Weekly Charter Market during the Easter period in 2018. Clarification has also been sought should Mr Jones now prefer to no longer participate in the arrangements for Droitwich Spa. During the elapsed timescale since the last Charter Market which took place before Christmas 2017, further enquiries have been received from other local operators. [*For information only*].

5. Christmas Lights Contract Renewal - Pursuant to Minute Number 197 of the Community & Amenities Committee meeting held on 15 January 2018 the Assistant Town Clerk confirms having met with Mr Rob Hollingsworth, representing the Festive Lighting Company on 20 February 2018. Design specifications are currently being produced and will be received for approval in due course. Consideration has been requested towards improved Christmas tree lights, some refreshed motif designs and additional decorations provision in the High Street area. The popular roof line icicle lights have been retained for St Richard's House and also put forward as an option for the Saltbarrow Market wrought iron archway, adjacent St Andrew's Church. *[For information only]*

6. Councillor S Best, Mayor – St Richard's Festival 2018, Sunday 6th May 2018. Forward Notification of a Mayor's Reception taking place to welcome an historic salt carrying barge to Droitwich Spa during the Sunday morning of the Festival Weekend. This is a component of a wider celebration of the Droitwich Spa Salt Heritage taking place during the Festival this year. It is anticipated that the Mayor will partake in supervision of the traditional unloading by hand of a consignment of salt derived from different parts of the world. The salt will then be modelled into a sculpture for display in Vines Park and then the Heritage Centre. This sculpture project is being coordinated and presented by Katy Beinart representing the Canal & Rivers Trust, as part of the Mid Worcestershire Ring's, Arts on the Waterways programme. Invitations for the reception hosted by the Mayor have been sent to local civic dignitaries and all Town Councillors. *[For information only]*
