276 SOUTH WORCESTERSHIRE DEVELOPMENT PLAN: CONSULTATION ON TRAVELLER AND TRAVELLING SHOWPEOPLE SITES

The South Worcestershire Councils (SWC) i.e. Malvern Hills District, Worcester City and Wychavon District were preparing a Traveller and Travelling Showpeople Site Allocations Development Plan Document to identify sufficient land for Traveller and Travelling Showpeople sites in order to meet the requirements of the recently adopted South Worcestershire Development Plan (Policy SWDP 17).
