*Further, Councillor T J Noyes to advise upon Application 17/01164/TC Proposed installation of a 15.0m monopole supporting 3 no antenna, 2 no dishes associated ground based equipment cabinets and ancillary development thereto, Land at Junction of Tagwell Road and Worcester Road, CTIL & Vodafone Limited (the Town Council having registered no objections to this application).*

5. Decisions of the Local Planning Authority:-
- a Approval Notices: Wychavon District Council, the Local Planning Authority, has issued four approval notices, all of which accorded with the recommendations of the Town Council.
  - b Refusal Notices: no refusal notices have been issued.
  - c Withdrawal of Planning Application W/16/02742/RM - Application for reserved matters following outline planning permission reference W/11/01073/OU for appearance, landscaping, layout (including the demolition of The Firs) and scale for 241 dwellings (Phase 1) including areas of open space not in accordance with condition 4 (Ref. W/15/01418/RM) with regard to drawing numbers, where changes are proposed to the internal layout; materials and enclosure plans, Land North of Pulley Lane and, Newland Lane, Newland, Droitwich Spa, Miss G Hallam. The application was withdrawn by the Applicant on 14 July 2017.
6. Worcestershire County Council – North Bank, Berry Hill Industrial Estate, Droitwich - Proposed Prohibition of Waiting At Any Time Order [*plan attached*]

*Drawing 2014-771-1 shows a proposal to introduce a Prohibition of Waiting At Any Time Order on the east side of North Bank on Berry Hill Industrial Estate in Droitwich. This proposal is to assist Heavy Goods Vehicles in particular when turning from North Bank into the access road leading to the various units. Currently due to vehicles parked on North Bank access and manoeuvrability are proving very difficult and by slightly extending the existing double yellow lines around the junction corner and along North Bank this should alleviate such problems; however there will still be parking space left on North Bank. The proposal has the support of the local member, County Councillor Richard Morris. Comments thereon have been requested by 1 August.*

7. Worcestershire County Council – Proposed Prohibition of Waiting At Any Time Order – College Green and Worcester Road [*plan attached*]

*Drawing 2017-668-1 shows a proposal to introduce a Prohibition of Waiting Order on College Green around its junction with Worcester Road, following a request from the local County Councillor G R Brookes, in response to complaints about obstructive parking around the junction. Views have been requested thereon by 10 August.*

8. Worcestershire County Council – Proposed Prohibition of Waiting At Any Time Order – New Chawson Lane, Colford Close, Oakleigh Road and Barns Croft Way [*plan attached*]

*Drawing 2017-614-1 shows a proposal to introduce a Prohibition of Waiting Order along New Chawson Lane, and around its junctions with Colford Close, Oakleigh Road and Barns Croft Way following a request from the local member as a result of complaints received from residents about obstructive and hazardous parking, making exiting the various junctions particularly difficult. Forward visibility is also reduced between Oakleigh Road and Barns Croft Way as a result of obstructive parking. These proposals have the support of the local member, County Councillor, Richard Morris. Views have been requested thereon by 11 August.*

9. Worcestershire County Council – Proposed Prohibition of Waiting At Any Time Order – Kidderminster Road [*plan attached*]

*Drawing No 2016.998.2 shows a proposal to implement prohibition of waiting 'at any time' parking restrictions on a section of Kidderminster Road, to address problems which are largely generated by railway parking and will specifically prevent parking in the following areas:*

- *Narrowing under both railway bridges*
- *Junction of Kidderminster Road/Vines Lane*
- *Travis Perkins Entrance*
- *Road leading to roundabout with Salwarpe Road*

*The proposals are considered necessary to maintain the safe free flow of traffic. Comments have been requested thereon by 17 August.*

10. Worcestershire County Council - Road Traffic Regulation Act 1984 (C2086 Pulley Lane, Droitwich Spa) (Temporary Closure) Order 2017 (*notice attached, for information only*)
