255. WORCESTERSHIRE COUNTY COUNCIL

Worcestershire County Council –Road Traffic Regulation Act 1984, Section 14 (as amended). Notification of Closure of Kidderminster Road with provision to continue for a maximum of 5 Days in order to facilitate new/replacement water main works. Anticipated start date is 8 April 2019. The section of closure is for Kidderminster Road from its junction with Hampton Road to the intersection with North Street on Union Lane. The making of the order was noted.

256. WORCESTERSHIRE COUNTY COUNCIL

Worcestershire County Council- Road Traffic Regulation Act 1984, Section 14 (as amended).
