6. Worcestershire County Council – New Chawson Lane, Colford Close, Oakleigh Road and Barns Croft Way, Droitwich – Proposed Prohibition of Waiting At Any Time Order *[plan attached]*

Pursuant to Minute No 84, Planning Committee meeting 31 July 2017 with regard to the above, Worcestershire County Council has submitted drawing 2017-614-1A which contains additional proposed restriction following advice from the police and discussion with the local member, County Councillor Richard Morris. The additional proposed double yellow lines on New Chawson Lane, opposite the junction with Barns Croft Way are to minimise any inappropriate parking displacement and safeguard visibility at the pedestrian crossing point on the north side. The rest of the original proposals remain. Comments have been requested by 14 September 2017.

Parking would be Mon – Sat 8am – 6pm for 3 hours only and no return within 2 hours. The proposal has the support of local County Councillor R J Morris and Town Councillors were asked for their views on an individual basis, comments thereon having been requested thereon by 31 August. No objections to the making of the Order were submitted.
