72. REQUEST FOR AMENDMENT OF ROAD NAME

Request for amendment of Road name from Packington Road to Pakington Road in Droitwich Spa. Residents have notified the Town Council of the spelling issue which appears to be a historic anomaly. The responsibility for Street naming and registration is maintained by Wychavon District Council. The Town Council's involvement would be to carry out a consultation of the residents of the road to determine a consensus of opinion for the change request, which in turn would enable Wychavon to take the matter forward. Residents have actually undertaken their own petition exercise which is equivalent to a consultation. All residents except 2 have signed to support the requested change of spelling. Reference has also been received that individual property deeds already accord with the preferred spelling and as such there should not be the requirement or any connected costs associated with amendments. The petition / consultation has been forwarded to WDC on 5 July 2021 with a request to consider progressing the change of spelling [for information].
