MINUTES of the Extra-Ordinary meeting of Droitwich Spa Town Council held in the Main Hall, Community Hall, Heritage Way, Droitwich Spa on Monday 15 May 2023 at 5.45pm.

APOLOGIES for absence: Councillor RCC Deller.

The Mayor preceded by the Mace-bearers and attended by the Town Clerk entered the Main Hall in procession. Ex – Councillor Mr Edgar Harwood was seated on the front row of the audience for the start of the proceedings.

1. HONORARY ALDERMAN – MR EDGAR HARWOOD

Pursuant to Minute No 258 of the Meeting of Full Council held on 27 January 2020, the Mayor invited Councillor RJ Morris to put forward his formal motion for the conferring of Honorary Alderman status upon ex-Councillor Mr Edgar Harwood.

Councillor RJ Morris proposed that 'Pursuant to the provisions of Section 249(1) of the Local Government Act 1972, to confer the status of Honorary Alderman of the Town of Droitwich Spa upon ex-Councillor Mr Edgar Harwood in recognition of the eminent service he has rendered to the Town as an elected member of the Town Council and for his meritorious services to the town in both a civic and non-civic capacity.

Councillor Morris spoke in support of the motion.

"Oyez, Oyez, Oyez!

Mr Mayor, Members, Officers and good people of Droitwich Spa.

We gather tonight for serious business:

That the Town Mayor and Councillors of the Town of Droitwich Spa, acting by the Town Council, do hereby admit Edgar Harwood to be an Honorary Alderman of the Town of Droitwich Spa in recognition of his eminent services rendered to the Council as a past member of the Town Council and for his meritorious services to the town in both a civic and non-civic capacity".

It is with great pride that I lead this nomination, Edgar has served this Town so well in many capacities, be it as Councillor, Round tabler, Rotarian, Norbury Theatre and surely the best infamous Town Crier to name a few.

In 2007 Droitwich witnessed its worst floods for many years. As Town Mayor I supported the Salvation Army and Wychavon District staff at the Community Hall which acted as a rescue centre for People stranded on the motorway network but whilst here, we became aware that certain areas of Droitwich were flooding and started to rescue and support our own residents.

I remember on the Saturday morning standing In Droitwich High St and seeing it flooded like a bath, I then had a tap on my shoulder from Edgar who said if I started a flood relief fund, he and rotary would support me. From that moment we started weekly meetings, drew in the Lions club, British Legion, and others. We supported and called on everyone affected and helped with meals, clothing, furniture, Rotary supported holidays, and many other areas of support.

Raising over 6,000 in a matter of weeks. Whilst many helped in this, I do believe that Edgar was instrumental in this happening and am very thankful.

Edgar has Droitwich at his heart and has proven over the years that he will support any activity he can that helps promote the Town and the people of Droitwich.

In 1980 he became Town Crier of Droitwich Spa after winning a competition at the Carnival. He was British Champion in 1984 and Runner up World Champion in 1986 – Taking Droitwich internationally.

I know others want to speak and honour Edgar, so I will move to admit Edgar Harwood to be an Honorary Alderman of the Town of Droitwich Spa Oyez, Oyez.....

The Mayor asked for consideration to temporarily suspend Standing Orders for the reason to enable Mr Alan Humphries to speak in support as a member of the public. This was proposed by Councillor RJ Morris, seconded by Councillor J Grady with all Members voting in favour.

<u>Resolved</u> – To temporarily suspend Standing Orders in order to enable Mr Alan Humphries to speak in support of the proposal to confer Honorary Alderman Status upon ex - Councillor Mr Edgar Harwood.

Mr Alan Humphries read out a statement of support.

Councillor AM Sinton seconded the motion and read out a statement of support. Councillor Val Humphries as Leader of the Labour Group on the Town Council expressed support for the motion on behalf of the Opposition Elected Members.

The motion, upon being put to the vote, was carried with just one abstention notified by Councillor DI Davidson for the reason that he has a pecuniary interest through an existing garage tenancy arrangement with Mr Edgar Harwood.

RESOLVED

That We, the Mayor and Councillors of the Town of Droitwich Spa, hereby admit ex Councillor Mr Edgar Harwood to be an Honorary Alderman of the Town of Droitwich Spa in recognition of the eminent service he has rendered to the community as an elected member of the town and for his meritorious services to the town in a non-civic capacity.

By permission of the Mayor, the Town Clerk then proceeded to administer the Alderman's Oath, this being duly taken and sworn by ex- Councillor Mr Edgar Harwood. The Oath was then signed and witnessed by the Town Clerk. The Mayor presented an illuminated Certificate of Admission as an Honorary Alderman of the town of Droitwich Spa to ex-Councillor Mr Edgar Harwood and offered congratulations on behalf of the Council and people of the Town. Mr Harwood responded, thanking the Town Council for the honour bestowed upon him and giving a brief summary of the actions and assistance he had received from many people and Family.

The Mayor, & Honorary Alderman then invited all present to join them for refreshments in the John Corbett Room which would take place immediately following the conclusion of the next Meeting which was the Annual Council (AGM). The Mayor declared the meeting closed and retired from the Chamber in procession.

ELECTION OF MAYOR 2.

There being no other nominations, it was resolved as follows. There were sixteen in favour - unanimous from the Members present.

That Councillor Mrs K Fellows be duly elected Town Mayor RESOLVED for the ensuing municipal year.

Councillors GA Duffy and Mrs K Fellows retired from the meeting and exchanged robes.

Upon return, Councillor Mrs K Fellows made the statutory acceptance of office before the Town Clerk.

Councillor Mrs K Fellows, Mayor - In the Chair.

The Mayor introduced her Consort, Mr Derek Fellows and presented him with the badge of office.

3. ELECTION OF DEPUTY MAYOR

The Mayor invited nominations for the Deputy Mayor.

It was proposed by Councillor RJ Morris and seconded by Councillor Val Humphries that Councillor AM Sinton be appointed to the office of Deputy Mayor.

Councillor Morris read out the following statement of support.

"It is good that we give Councillors who have served a term on Council the opportunity to be Mayor for the first time.

I am pleased to nominate Cllr Alex Sinton, many will know Alex has just completed the Chairmanship of Wychavon and carried that role out with style and aplomb, fully supported by Eleanor. His experience, ideas and motivation for Droitwich will bring rewards for our Town."

There being no other nominations, it was resolved as follows. There were sixteen in favour – unanimous from the Members present.

Councillor AM Sinton signed the acceptance of office before the Town Clerk and then the Mayor presented him with the Deputy Mayor's badge of office. Councillor Sinton introduced his Consort – Mrs Eleanor Sinton and the Mayor presented the Deputy Mayor's Consort badge.

Supporting Droitwich football club coming back to Town and cheering them all the way to the Play offs, opening events, residential homes, new shops amongst many other activities. George has been fun, committed to duty and given the position of Droitwich Mayor a youthful vigor. Thank you, George, and well done!"

RESOLVED

That a Vote of Thanks to Councillor GA Duffy for his year as Mayor 2022/2023 be given.

Whereupon the Mayor presented Councillor GA Duffy with the Past Mayor's Jewel.

5. REPLY BY THE OUTGOING MAYOR

Councillor GA Duffy responded by advising that it had been a great honour to wear the chain of office and to represent the Town throughout the past year. He wished the new Mayor a very enjoyable term of office. Councillor Duffy read out the following statement of thanks.

"Thank you for your kind words after what has been a truly historic year. I look forward optimistically to what opportunities this year will bring for our town, our council, and our

new Mayor, Mrs Kate Fellows. For me though, I cannot see it being as memorable or as much of an honour as I had in being surrounded by the people of Droitwich Spa at events I wholeheartedly thank our dedicated town council officers for such as celebrating our late Queen's Platinum Jubilee, people of Ukraine's Memorial, Queen Elizabeth's Memorial, my own Civic Service, our Christmas Lights Celebration, and the Coronation King Charles as well as having the pleasure of supporting a miriad of community hosted events throughout the town.
