Guidance notes on completing Form 3 of the Annual Governance and Accountability Return 2022/23

1. Every smaller authority in England that either received gross income or incurred gross expenditure exceeding £25,000 **must** complete Form 3 of the Annual Governance and Accountability Return at the end of each financial year in accordance with *Proper Practices*.
2. **The Annual Governance and Accountability Return is made up of three parts, pages 3 to 6:**
 - The **Annual Internal Audit Report** must be completed by the authority's internal auditor. ✓
 - **Sections 1 and 2** must be completed and approved by the authority. ✓
 - **Section 3** is completed by the external auditor and will be returned to the authority.
3. The authority **must** approve Section 1, Annual Governance Statement, before approving Section 2, Accounting Statements, and both **must** be approved and published on the authority website/webpage **before 1 July 2023**.
4. An authority with either gross income or gross expenditure exceeding £25,000 or an authority with neither income nor expenditure exceeding £25,000, but which is unable to certify itself as exempt, or is requesting a limited assurance review, **must** return to the external auditor by email or post (not both) **no later than 30 June 2023**. Reminder letters will incur a charge of £40 +VAT:
 - ✓ • the Annual Governance and Accountability Return Sections 1 and 2, together with
 - ✓ • a bank reconciliation as at 31 March 2023
 - ✓ • an explanation of any significant year on year variances in the accounting statements
 - ✓ • notification of the commencement date of the period for the exercise of public rights
 - ✓ • Annual Internal Audit Report 2022/23

Unless requested, do not send any additional documents to your external auditor. Your external auditor will ask for any additional documents needed.

Once the external auditor has completed the limited assurance review and is able to give an opinion, the Annual Governance and Accountability **Section 1, Section 2 and Section 3 – External Auditor Report and Certificate** will be returned to the authority by email or post.

Publication Requirements

Under the Accounts and Audit Regulations 2015, authorities must publish the following information on the authority website/webpage:

Before 1 July 2023 authorities **must** publish:

- Notice of the period for the exercise of public rights and a declaration that the accounting statements are as yet unaudited;
- **Section 1 - Annual Governance Statement 2022/23**, approved and signed, page 4
- **Section 2 - Accounting Statements 2022/23**, approved and signed, page 5

Not later than 30 September 2023 authorities **must** publish:

- Notice of conclusion of audit
- **Section 3 - External Auditor Report and Certificate**
- **Sections 1 and 2 of AGAR** including any amendments as a result of the limited assurance review.

It is recommended as best practice, to avoid any potential confusion by local electors and interested parties, that you also publish the Annual Internal Audit Report, page 3.

The Annual Governance and Accountability Return constitutes the annual return referred to in the Accounts and Audit Regulations 2015. Throughout, the words 'external auditor' have the same meaning as the words 'local auditor' in the Accounts and Audit Regulations 2015.

Guidance notes on completing Form 3 of the Annual Governance and Accountability Return (AGAR) 2022/23

- The authority **must** comply with *Proper Practices* in completing Sections 1 and 2 of this AGAR. *Proper Practices* are found in the *Practitioners' Guide** which is updated from time to time and contains everything needed to prepare successfully for the financial year-end and the subsequent work by the external auditor.
- Make sure that the AGAR is complete (no highlighted boxes left empty) and is properly signed and dated. Any amendments must be approved by the authority and properly initialled.
- The authority **should** receive and note the Annual Internal Audit Report before approving the Annual Governance Statement and the accounts.
- Use the checklist provided below to review the AGAR for completeness before returning it to the external auditor by email or post (not both) no later than 30 June 2023.
- The Annual Governance Statement (Section 1) must be approved on the same day or before the Accounting Statements (Section 2) and evidenced by the agenda or minute references.
- The Responsible Financial Officer (RFO) must certify the accounts (Section 2) before they are presented to the authority for approval. The authority must in this order; consider, approve and sign the accounts.
- The RFO is required to commence the public rights period as soon as practical after the date of the AGAR approval.
- **You must inform your external auditor about any change of Clerk, Responsible Financial Officer or Chairman, and provide relevant authority owned generic email addresses and telephone numbers.**
- Make sure that the copy of the bank reconciliation to be sent to your external auditor with the AGAR covers all the bank accounts. If the authority holds any short-term investments, note their value on the bank reconciliation. The external auditor must be able to agree the bank reconciliation to Box 8 on the accounting statements (**Section 2, page 5**). An explanation **must** be provided of any difference between Box 7 and Box 8. More help on bank reconciliation is available in the *Practitioners' Guide**.
- Explain fully significant variances in the accounting statements on **page 5**. Do not just send a copy of the detailed accounting records instead of this explanation. The external auditor wants to know that you understand the reasons for all variances. Include complete numerical and narrative analysis to support the full variance.
- If the bank reconciliation is incomplete or variances not **fully** explained then additional costs may be incurred.
- Make sure that the accounting statements add up and that the balance carried forward from the previous year (Box 7 of 2022) equals the balance brought forward in the current year (Box 1 of 2023).
- The Responsible Financial Officer (RFO), on behalf of the authority, **must** set the commencement date for the exercise of public rights of 30 consecutive working days which **must** include the first ten working days of July.
- The authority **must** publish on the authority website/webpage the information required by Regulation 15 (2), Accounts and Audit Regulations 2015, including the period for the exercise of public rights and the name and address of the external auditor **before 1 July 2023**.

Explanation Note AGAR Submission 2021/2022 and resultant “No” response made for Assertion 2 of AGAR (Page 4) Submission for 2022/2023.

1. Original Narrative Statement from 2021/2022 AGAR- (dated 7th July 2022)

The External Auditor has brought to the Town Councils attention on 6th July 2022 correspondence which raises that it has been alleged that the Council's financial regulations have not been complied with since FR 5.2 states that “a detailed list of all payments shall be disclosed within or as an attachment to the minutes of the meeting at which the payment was authorised”. This is for the year end period 2021/2022.

Following the advice of the External Auditor an amended AGAR response to Assertion 2 has been submitted and published as at 7 July 2022 with an accompanying note. Going forward this matter will be noted and included as part of the agenda for the next scheduled Full Council meeting on 26 September 2022. This will also include the next due annual review of the Financial Regulations and the recommendation to ensure all individual remittance payment lists are appended separately to the website with the accepted minutes going forwards.

This was in the context that the full lists of individual cheque remittances and reviewed regular automated payments had not been attached to the website page for the relevant Council Meeting minutes from 2018.

The External Auditor Lead Officer (Rebecca Plane – Head of Challenge for PKF) has agreed this statement and the corrective measures being taken forward on 7th July 2022. Final confirmation for suitability of the actions taken and in place was provided by the same on 7th December 2022 & 3rd January 2023.

2. Narrative Statement for 2022/2023 AGAR

The matter from 2021/2022 has been fully discussed with both the External and Internal Auditors from July 2022. It has been agreed that the corrective actions taken are suitable in that the last two years (2020/2021 and 2021/2022) remittance payment lists have been retrospectively attached to the section of the website with the accepted Council Meeting minutes. All remittance lists and regularly reviewed lists of automated payments are now added to the website moving forwards from December 2022. The matter arising and the corrective measures taken have been fully reported and minuted as part of Full Council Meetings (Sept & Dec 2022, January & April 2023- for conclusion of the 2021/2022 AGAR and period).

For the reason that the challenge correspondence raised the matter in June and July 2022, the period extends to the 2022/2023 year. To this effect there is a requirement to answer assertion two (page 4) of the 2022/2023 AGAR as “No”, together with providing this accompanying explanation note.
