104. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended).
First Notice of Order for Temporary Road Closure of C2254 Ombersley Way, Droitwich Spa. The proposal is to close the section from the junction of U41720 Briar Mill with C2254 Ombersley Way.
