  - (a) Approval Notices: Wychavon District Council, the Local Planning Authority, has issued 8 approval notices since the last Town Council Planning Committee Meeting on 24 July 2023. Of these all 8 did accord with the recommendations of the Town Council Planning Committee *[for information]*.
  - (b) Refusal Notices: Wychavon District Council, the Local Planning Authority, has issued no refusal notices since the last Town Council Planning Committee Meeting which took place on 24 July 2023 *[for information]*.
6. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). First & Second Notices of Order for Temporary Road Closure of U41708 Ledwych Close, Droitwich Spa. To close the section between the junctions of U41716 Archers Close and U41712 Stouton Croft. For the reason to enable carriageway resurfacing by WCC Highways. Anticipated duration is 14 days from 22 August 2023 *[public notice and location details attached for information]*.
7. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). Second Notice of Order for Temporary Road Closure of C2254 Ombersley Way, Droitwich Spa. To close the section from the junction with U41720 Briar Mill to C2254 Ombersley Way. To enable carriageway resurfacing by WCC Highways. Anticipated duration is 14 days, commencing 10 August 2023 *[public notice and location details attached for information]*.
8. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). Second Notice of Order for Temporary Road Closure of C2076 The Holloway, Droitwich Spa. To close the section from the junction with B4090 Hanbury Street to the junction with C2076 Charles Henry Road. To enable carriageway resurfacing by WCC Highways. Anticipated duration is 2 days commencing 3 August 2023 *[public notice and location details attached for information]*.
9. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). Permitted Parking Area and Special Parking Area - Waiting Restrictions and Street Parking Places Consolidation Order 2004 (Variation) and Order 2023 for prohibition of waiting on Union Lane, Droitwich Spa. For the reason to facilitate the passage on the road of any class of traffic. *[The draft order, statement of reasons, public notice and location plan are all attached for information]*.
10. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). Proposal to implement Prohibition of Waiting at Any Time restrictions on both sides of Bourne Close, Droitwich Spa, including the junction with Harris Close. The proposal follows a request made by the Local Police Team due to difficulties for motorists being caused by obstructive parking. The main concern is maintaining safe access for larger vehicles including the emergency services. The proposal; is supported by the Local WCC Elected Member – Councillor RJ Morris. vehicles making deliveries The West side of the road already has an existing order granted for the prohibition of waiting/parking at any time.
