This document lists the comments made by respondents to the questionnaire survey which was undertaken to inform the Droitwich Spa Neighbourhood Plan in October 2023.

Several of the survey questions were open, inviting free-write comments or suggestions on aspects of land use and development. The resultant responses are set out in the following tables, taking each question in turn. The comments have been summarised in terms of the main themes raised (see the Results Report).

Free-write comments provided on the printed questionnaires (as distinct from online) were entered onto SurveyMonkey by the Town Council.

# **Vision and Objectives**

# Question 2: If you have any comments on our Vision and objectives please tell us in the box below:

Agree with the vision statement which are general and non specific but do not necessarily agree with the specific vision of reinstated brine baths which might not be necessary for a distinctive spa town sense of place or protected heritage

There needs to be a guarantee to ensure delivery of the vision and objectives - not just empty promises! Droitwich Spa seems to be a poor relation to towns such as Evesham. There doesn't seem to be much provision for young people

To stop the town from spreading further. We are fast losing the sense of belonging. I find the people of Droitwich are kind, helpful and considerate. When I visit Worcester I sense a very different feeling. People in many places seem less friendly and uninterested in their role

I am concerned about all the empty premises in the town centre. The reinstatement of the Brine Baths is also vital for the generation of the town

Sustainability, supporting infrastructure, regeneration of the centre. Spa town character. Should be objectives before housing is developed. Local peoples needs to be addressed and catered for before new communities are offered new housing developments. Family links to residents is key to maintain heritage of this spa town. Newcomers welcome and need to be built on this history before Droitwich is overgrown by housing developments.

How about places to stay for tourists and visitors - hotels, b&b's, self catering units and caravan sites

Some serious work seems to be needed on the traffic lights area by David Neville to prevent flooding in that area.

I hope community facilities includes NHS GP practices

The ridiculous traffic queues at Copcut/Pulley Lane junction/traffic lights must be sorted. Totally unacceptable. The staged road cross at start of Hanbury Road must be sorted when the development takes places. Yes it will cost but so does the everyday problems - delay/pollution etc

To ensure the town has quality and affordable hotel accommodation

Walking and cycling are only feasible for younger people. In an aging population there should be an efficient public transport service to discourage use of cars

I think enough is enough now to many new developments we have enough housing around us

Infrastructure is key to any development and is the only way to assure sustainability but it feels like too often bolt ons are considered adequate (eg disastrous road layout at Copcut and resulting huge change in traffic / environmental pressures)

Droitwich is unique in the fact that it does not have any large chain takeaway outlets & I would not want the regeneration of the town to include those. I think that any new housing should be developed for existing young residents of Droitwich and not sold to investors.

Walking and cycling is unrealistic in a rural town. Do you expect people to walk/cycle miles home with bags of shopping?

The agreement is depending on amount of housing and loss of green belt. Already saturated by new housing, without any additional infrastructure being put in place.

We definitely require the return of the Brine Baths. We need the Chateau Impney successful planning application to be implemented without delay. The Chateau is iconic for the town. Infrastructure needs to be in place, PRIOR to any new development.

Not at this time

They are not being met. Shops closing. Empty shop space. Too many houses being built with no increase in infrastructure such as additional doctors surgeries, dentists, schools play areas, nurseries

I would like a central community for people to meet not more houses directly in town centre.

I strongly believe that any future development for Droitwich should be kept to the West of the M5 to preserve the beauty and ethos of the countryside and rural way of life

The brine baths should be a key priority, along with a greater focus on promoting the town's unique history (e.g. Roman era, salt, John Corbett, Chateau Impney). Increased tourist numbers would benefit the local economy. The "spa" should be put back into "Droitwich Spa"! Any redevelopment/regeneration should be done in keeping with the town's heritage. In particular, the distinctive character of the High Street should be embraced - it offers lots of potential for independent shops. Buildings such as the Raven Hotel should not be left to decay. Lessons need to be learned!

I appreciate the need for new development/housing but hope the objectives will hold true to protecting the size/greenness of the town. Many people choose to live here because it is a small market town with plenty of green space and access to open countryside so I do hope this won't be lost in new development.

I think that you are correct to be aiming to concentrate on the historical and cultural aspects of the town alongside important environmental considerations.

Would like a community hub in the town centre that provides opportunities for those who need more support, eg getting back into work or supportive work, eg little coffee shop in the hub. Hub also to house repair centre to help teach people how to fix things, rather than throwing it away. Hub also to be donation station for food, clothing and furniture to help those in need and reduce waste. People can then come and shop for free or in exchange for eg volunteering. Can run sessions here with the social prescribing team.

Please maintain and develop the wide range of leisure facilities that the town has. Support local amateur groups and encourage commercial ventures. Maintain the road network, urban environment and encourage work and business

The vision should concentrate more on offering the community a far better GP/Dentist/School and transport facilities improving it's current failing infrastructure

Can we look after "residents" of Droitwich first before immigrants

You'd better get a move on because the town is falling apart - just a commuter centre

Ensure that brownfield sites are utilised in a way which supports the vision and that heritage is embraced

Don't ask for public opinion after a plan has been finalised. Inform how people can get involved in design, give ideas and improvements. Have a body that has some sway to push these ideas given rather than ignore.

Please do not permit building new houses without mandating via s.106 agreements the necessary infrastructure to support new residents.

1. The 1970's precinct is dated & full of charity shops. Depressing. Convert exterior to mixture of retirement housing, offices & craft workshops. Convert internal to sidewalk cafes, restaurants & tourist hotels facing a central grassed square, full of flowers. 2. High St is full of variety of interesting shops; encourage more. Restore 15th century historic buildings on High St. Paint colours. Pave street with attractive stones, erect benches, street lighting and trees. 3. Restore Brine Baths and Raven in a style that enhances character of town. 4. Preserve open green space

The objectives are too vague. I would like to see specifics. Also, there has been far too much out of town building for new houses on Greenfield land. If new houses/flats needed the council need to start regenerating the unused land in the town centre ie. the old disused Raven Hotel and land towards the motorway. Also, highways have done a rubbish job at planning the roads for new housing estates around the Copcut. More needs addressing here.

there is insufficient detail

The town is too overpopulated with housing which has paid no consideration to the available services and infrastructure. It cannot accommodate more housing without more schools, GP's, leisure facilities etc. first.

Whatever the vision, the infrastructure must be provided in the form of safe roads and drainage

If you are clear in wanting to achieve more tourism, much more emphasis needs to be given to making the Droitwich canals attractive and welcoming, which they are not at present, due to conflicting aims about environmental issues.

I agree with all aspects EXCEPT the provision of even more housing. New housing has already swallowed up neighbouring villages and communities which have consequently lost their identities. I agree with the general statements made in the Vision and Objectives, but would be interested in what the future plans for the station would be. It seems to have outgrown its current, congested site. Additionally, I'd like more specifics about how road networks are to improved. The junction at the Copcut Elm is nightmare, with traffic regularly backing up beyond the roundabout by The Ridings. Finally, it seems to me that local services, (GP surgeries, school provision) have not kept up with the growth in housing developments. All of the above need to be considered if Droitwich is to maintain it's distinctiveness and continue to be a pleasant place to live.

Droitwich was a small Spa town which was attractive to visitors & residents alike, with continued development & growth the infrastructure is at breaking point, roads are continually gridlocked around the town which was previously never the case even with a motorway closure. Another cause of concern being schools, for example Westacre Middle school, parents parking on the grass

verge obscuring the crossing area, i have previously written to the head who also has concerns & approached both the Police & council about the dangers when collecting children. With more housing, we will need more medical centres, pharmacies, dentists etc ... It's impossible to get a Dr appointment now let alone more housing occupancy???

Most important to have infrastructure in place before adding to housing

Whilst understanding the need for housing, we must also protect our beautiful surrounding countryside and lanes. Current developments have resulted in roads becoming rat runs which is dangerous for cyclists, walkers and nature

With the amount of new houses being built more schools and doctors surgeries would be good. The reinstating of the brine baths is very important

Good to see the town moving forward

Encourage people to visit the town by being more proactive to encourage smaller retailers and to provide more free parking to make it easier for access to the retailers.

Encourage more restaurants. Ensure house builders improve infrastructure and facilities to meet needs of increased population

The main concern is the increase in housing - building on greenfield sites- which does not have the desired effect of increasing use of the town centre. I believe mostly because of parking charges that don't allow businesses to compete on a level with out of town retail. Also, the aim to create infrastructure before housing development has failed miserably, evidenced by overwhelming numbers at medical practices and pharmacies and enormous traffic congestion and speeding.

New housing must not be allowed to keep growing making Droitwich into a computer town.

Suitable new housing should also take into consideration wider community impact eg traffic, healthcare, parking, schools

Extremely ambitious but potentially requiring significant financial input. Can a small town council realistically deliver this vision and these objectives?

The vision mentions the town centre being a safe and attractive public realm. Why is this vision limited to the town centre? Surely the whole town should be this, and the vision should reflect that.

Infrastructure for cycle and walking provisions. So that means a 15/20 minute town? That's exactly what this means!

Full review of buses routes and times

Recent housing developments around Pulley lane and Copcutt/Salwarpe have damaged the views around Droitwich and also created large areas of tarmac and fencing which is impassable to wildlife. Future developments within Droitwich should be focused on using lots of derelict land within the town environs to avoid further sprawl

No, happy with the overall outline. The only concern is keeping the town as vibrant and interesting as possible with a good range of shops, cafes & restaurants so it fulfils the size of this growing town.

I agree with most of both, but would like to see statements prioritising development of brown field sites and protecting green belt and surrounding countryside

Transport; especially Sunday travel needs to be a higher priority: integrated transport too.

In my opinion there are far too many housing estates/new development areas which are unfortunately not adequate ie the new Cop Cut estate which causes havoc with traffic at the new traffic lights so it has not been well thought through. The traffic management system at the Cop Cut is a total nightmare due to the new housing estates.

Objectives should include protecting green open spaces

I generally agree however do not support any more housing, the current infrastructure does not support the housing we currently have and no redesign will support further development. The current road structure is in a diabolical state and the Copcut Elm lights are worse than ever.

We need to ensure we have action plans in place that are both meaningful, measurable and achievable.

There is a lack of thinking outside the box. It appears bland and safe without originality or youthful vision. Indeed lack of "youth" is a notable omission.

Regeneration of the town centre with a variety of shopping options. Improved disabled access to the town centre from populated areas within the town of Droitwich.

The town needs a theme to attract investment and people basing this around the history of Droitwich is clearly sensible

Whilst I agree with most of the statements, I do not think we need any more new housing to meet our community needs. The recent developments at Yew Tree Hill and Copcut I feel are sufficient for the area. We need to maintain a green belt around our beautiful town

A drop in centre for people with dementia in town where they could safely spend an hour or two whilst carers are shopping etc. More publicity for carers facilities locally

Your vision is inspiring but all the council see to care about at the moment is building more unaffordable housing. No planning whatsoever for infrastructure- mindsets must change dramatically

A bunch of words that express what any community wants and needs.

Need to think of how to regenerate the town centre. Concerns that it is becoming a bit of a ghost town. Review parking charges would help - more free parking would entice people to come in Stop building new houses we dont have enough doctors/dentists or schools to cope with all the new builds that we have now!

The vision and objectives seem reasonable though I have a general concern about planning guidelines being too much of an impediment to needed development of infrastructure and housing, particularly for the renewable energy transition that will be required.

Housing needs to be carefully thought out and not use the green spaces around Droitwich. There has already been too much development with no change to infrastructure

Its not about the vision and objectives, not many could disagree. However, its all about how those visions and objectives are achieved.

Why is there no mention of the local High School in the plan - it should be at the centre of the plan as it is the only high school in the town - it needs the help of the town to help the young population / next generation form and be part the future of the town

Better planning around new home development is required. The new lights by the Copcut Public House causes long and dangerous tail backs. An example of extremely poor planning.

Impossible to disagree as they are so bland

Education and healthcare must be the priority

Need to ensure the infrastructure of Droitwich is in line with the development & increase in housing & the population

The development of currently unused brownfield sites must be a priority, notably the site near the railway station

Housing for single people is important, as is truly affordable housing.

Make sure any new homes are built according to the agreed plans approved and infrastructure is put in place before any homes are built. We do not want another shambles of a road layout at the Copcut - it is a disaster

"Protect the environment", agree but in such a way that it is a common sense approach and is not a drain on the populate's personal finances

As long as infrastructure is provided it's good development plans.

Any further building/ housing projects MUST include associated infrastructure - hospitals, schools, GP surgery etc

The need to ensure any new building is built as sustainably as possible and that any planning of whatever sort is complimentary to the environment

Before any more development - more infrastructure MUST be in place - doctors, schools, car parking (preferably free), road improvements, utility services etc

You need to have some "strength" behind them e.g. pressure to ensure that historic/important buildings are improved and not just left to decay.

It would be good to have lighting along the main paths in the Lido Park especially in the winter months. It would also be good to see The Raven Hotel restored and the graffiti removed from the upper part of the building.

Agree with the Vision and Objectives, but perhaps worth calling out education and healthcare provision in the supporting infrastructure.

Droitwich is a small town, we just had 2 major housing developments. No more housing is needed Include providing more infrastructure as the town gets bigger, facilities fall short in all respects at present

As long as the infrastructure is matched alongside the number of people moving into the area,ie doctors dentist

I believe that creating facilities for the existing community and residents should be priority over creating more homes, although appreciate that this is necessary too.

All good as far as I can see

The employment aspects of the vision seem to ignore key aspects including Manufacturing - specifically including high tech manufacturing, Service industries, Transport and Distribution - a key opportunity for the town given our proximity to the motorway network from the midlands to the south west and south Wales; in addition it also ignore home working in the service industries which will only grow over the next 20 years, but will require greater technology connectivity and its associated infrastructure both requiring excellent mobile phone connectivity which is currently unavailable across the town and high speed broadband connectivity, if we are to prosper and grow as a town we need to include these in our vision and objectives

Along with good quality housing our vision and objectives need to reflect the need for the public services infrastructure - inc schools, doctors, leisure services transport hubs, etc, infrastructure to support the additional housing. in addition the vision and objectives ignore our role as a strategic county centre providing this infrastructure to the surrounding parishes and villages, if we do not include / reflect this in our vision and objectives the continuation of housing developments in the parishes on our boundaries will overwhelm our services and make our plan redundant

As you say, as long as infrastructure is in place including roads, facilities. I thought at one time there was talk of a dual carriageway to ease up A38/Worcester Road traffic?

I feel whatever regeneration of the town needs to be done sympathetically, so it doesn't compromise the town's character

The key issue relates to how large Droitwich will be. In the early 1960's the population was around 7,000 whilst it is now approaching 30,000, including the urban extension at Copcut Rise. Further growth is limited within the existing boundary. Droitwich should not be allowed to grow incrementally / piecemeal outside the existing boundaries. It requires a clearly defined, well thought plan as to its future size. This does not exist at the present time.

Service ratio to housing as no new services have been build, though some rebuilt and modernised, though hundreds of new homes being built.

Regarding new housing development, there should be a statement included to cover the need for local shops, schooling and medical facilities.

As long as it doesn't include LTN, ULEZ, 15 minute towns or any others control systems then I'm for keeping the heritage of Droitwich, it's a lovely town.

I think the key areas to highlight are balancing the need for housing with the need for environmental protection. I would hope the brown land that is in Droitwich would be used before green belts and as mentioned, the infrastructure to support it is in place. How this can be achieved when the NHS and education is underfunded is another matter.

As with all these 'plans', without supporting and expanded public services (e.g. local healthcare GP / NHS Dentist) the impact on the existing community becomes greater and negative. Your vision and objectives are excellent but as you can't even sort out the Raven Hotel I doubt you'll achieve any of your ambitions. The Raven is an eyesore and reflects very poorly on the ability of the council to do what is best for the residents of Droitwich.

Although response options are limited, I generally agree with the vision. However, I would like to note that more priority should be given to foot and cycle traffic across Droitwich and when it comes to planning and/or redesigning connecting roads to surrounding towns/villages. Actively encouraging people to walk/cycle more will not only have environmental but health benefits as well. More retail outlets

Regarding the regeneration aspect it is important that there is some cohesion between Victoria Square and the High Street. There is no linkage between these two retail areas not helped by the town's layout. Some years ago there was consideration into making the High Street pedestrianised with High Street traders opposed to this as they considered that their main trade came from those who parked up on the high Street and nipped in to one or two shops in the 45 minutes allowed. This is a short sighted viewpoint and visitors should be encouraged to stay and shop for a longer period than the permissible parking time zone. The empty and run down nature of the High Street demonstrates that on street parking has little bearing on economic growth in this area.

Why is there no reference to redevelopment of brown field sites, the plan should be specific in rejecting any future developments beyond the current housing footprint until all brownfield sites have been redeveloped which may involve mixed developments, social housing (good access to transport). Building more housing when the current infrastructure cannot even cope with existing residents is badly thought out idea. Traffic back up from CopCut island with road users causing gridlock as they sit on the island. In turn drivers find alternative routes often down country lanes that are not designed for heavy traffic. Pulley Lane has gone from a lovely country lane to a dangerous road where people in the new properties speed and throw rubbish without a care for the environment, animals or people. Comments re housing a concern...concerned that plan will be used by developers to over develop or turn town centre into residential properties

It's important, that to deliver the vision and objectives, strategic and tactical plans, predicted on multi-dimensional perspectives, scenario planning, risk and opportunity modelling are formulated. If this does not happen, in a robust and sustainable way, then the vision and objectives stated will be just good intentioned and lack bite.

# Question 9: If you have any other suggestions for how the Town Council could improve community life in Droitwich Spa, please tell us below:

With regard to a youth club, which we don't appear to have. Think it would be good to engage the young people in the planning prior to opening. needs someone who is especially keen to inform the youth by a meeting to hear what they would like. Posters could be put around the town to advertise a meeting. Also if the person is able to go to some of the places that the youth congregate eg outside Morrisons, in precincts or walking the streets, they would be given the chance to have their voice heard. there are a lot of young people who have nothing to do, nowhere to meet and some activities are too expensive for them. Nice young people who have no opportunities. Involve them in all the preparation. The meeting and form a committee of leaders and young people may need have a couple of small events to raise money, but any decisions must include the youth.

A good hotel within the town or just beyond would improve the town image. Better facilities for additional doctors services

clean replace road signs as they are seen every morning going to from work showing Droitwich as a dirty neglected place. in town replace broken slabs/block pavers alike with the same not a dob of tarmac again shows no one cares about town. these are simple fixes that can up lift the town like the nice displays of flowers and hanging baskets that have been done already. Repair the pavements and also free parking to encourage people to go into the town centre Make the westlands roundabout safe.

Improvements to pedestrian linkages have long been an issue in Droitwich. The crossings from the Westlands to the retail park over the A38 are needed because that's the shortest and most direct route. It needs to be traffic light controlled. The pedestrian links to the Lido Park need to be improved dramatically as does the link from the railway station to the Kidderminster Road. Why hasn't the

Legion site been developed? It had planning permission? Or are the council making it difficult again? The town needs more housing close to the retail core, rather than more housing miles to the south where new residents are more likely to disappear to Worcester for their shopping. There should be more development to the north of the town. The Raven needs to happen - why is the council holding things up? The developer should have started the build out by now, but as time has gone on and the council have delayed things, the cost of building has gone up and house values have started to go down. Will it be left to rot because of the council's delays? We talk about no more green field development, but the council make it too hard for brownfield sites to come forward, or it would have happened by now. We desperately need more affordable housing in the town and we really need to look at how the Westlands Estate can be improved because its design is letting it down, as is the quality of the housing there. We need to think about pedestrianizing the high street, even if its just on a Saturday as its such a nice place for people to visit and linger - if cafes could safely spill out onto the road (when closed) it would provide much more of a destination than it currently does. There is little opportunity to stand and appreciate the beautiful architecture if there are cars in the way and the pavements are far too narrow. Trial a Saturday road closure and give those who need it (i.e. shopkeepers) free parking that day. What happened to the last neighbourhood plan? We came to a couple of meetings but then nothing happened for ages. Why is one being prepared now as there have been missed opportunities to influence development at the Raven and at the Legion.

The town council should ask and listen to the views of Droitwich people. This current survey has taken too long to appear.

Our ideas are worthless if the council can't do the current basics and allow the town properties to become dilapidated, utilise the space currently afforded by derelict buildings (Raven) to be developed into affordable housing and community area.

When builders are allowed planning permission they should begin by building community contributions such as new school or medical centre to prevent overloading the town's existing facilities and ignoring the vast overloading their new estates will add to our already financially stretched local services. They should complete walking and cycle links to the town before they sell all the houses and leave some new arrivals marooned. Think of mobility scooter users: they need to be located suitably with proper pavement near links to town so their batteries don't go flat before they get home and the pavements do not 'run out' on the new estate roads.

Keep golf clubs tennis & swimming facilities, keep open space avoid too many houses that would overwhelm infrastructure, safe walking & cycling maintain canals

Less new housing. More activities for all ages

If you saw the chaos created by Copcutt traffic lights yesterday (20/10) the last thing you should be considering is more housing! A38 gridlocked from Ombersley island -NOT due to accident or flooding on Pulley Lane! Sons who travel that way daily despair with that road, island and traffic lights. It is IMPOSSIBLE to book NHS dentist or secure GP appointments - how will current services cope with more housing? Where have all the monies from current developments gone? Brine baths - still no progress. Raven - still no progress. Why do you allow developers so much power - Pulley lights are a prime example! Our son and partner, both grown up here, have made a conscious decision to purchase their first home outside Droitwich for all of these reasons, and moved to Worcester. We moved to the area almost 2 decades ago and you're still talking about the same developments - Raven, Brine baths, youth club, improvements to skate park, keeping shops open in town. The only visible thing are the numerous housing developments and worsened traffic and access to services!! We have loved living in Droitwich, but the continued developments are diluting the many qualities that we moved to this Town for.

Provide far more social housing but make it sustainable; improve access across the dual carriage way for Westlands residents, improve local facilities in Westlands and other estates, improve insulation and alternative forms of power in all housing and facilities

Reduce levels of traffic around Droitwich. Roads are so busy now, lots of people drive too fast for the conditions. Reduce speed limits and encourage walking and cycling more. No more houses until infrastructure, GPS and hospitals can cope.

In general I feel the Town Council balance a lot of different aspects for Droitwich for the benefit of various backgrounds and age groups, keep up the good work on a balanced approach to the community

Droitwich already needs more Doctors and Dentists, Pharmacies, pubs, and services. How can you build more houses until these are built first?

Better facilities and access for disabled people in the town, more and better positioned dropped kerbs, more disabled parking spaces.

Improve tourism. Launch a community buy-out of chateau Impney and create jobs running, maintaining, and opening major events at the park. Stop housing planning on greenbelt, use the extensive brown land in droitwich rail area to create a new retail town area but balance the whole scheme with tourism in the old town by an open pedestrian highway from the chateau to the new retail area. Old town becomes the restaurant and leisure area.

Housing suitable for the disabled. Filter lane off A38 to north Droitwich.

We have some wonderful pub buildings but too many are drink-focused and we have to leave for hadley, ombersley, Worcester for good lunch/dinner. We go along to support the local festivals but the layout and appearance could be improved (last festival seemed to be all metal barriers and was hard to navigate, stages small and hidden with no central area to draw people in) and would love to see more traditional stuff e.g. flower and produce show to draw more outside visitors rather than just locals.

Clearing pathways linking Burrish Street, Albert Street and Miller Street

Access to Spa/ Salters Medical Practice. Elderly and disabled are trying to dodge cars, taxis, buses and other traffic on a blind bend. The path down from the Old Library car park must surely contravene health and safety standards and there is no pavement around the Covercroft Centre.

At the Copcut junction (which has become a bottle neck) please allow more time for cars on the A38. The traffic light sequence allows only a short time, causing build up of traffic on Main Road/ A38

Car parking in High Street endangers pedestrians when transport heavy lorries appear

How about bus service to Corbett Health Centre? It is far from the town and has a big hill for elders to climb!

At the Copcut crossroads why on earth was the short footpath from Pulley Lane to the bus pull in removed? Folks have to cross the A38 instead now. The pedestrian lights would be better by M&S garage!

Its a shame graffiti can't be removed quickly as the evidence shows it reduces it. Its also a shame that the beautiful timber building in the High Street appears to be just sitting empty

I am new to the area so am unable to fill in the questionnaire. I am appalled that I have to pay to shop at Waitrose and know it comes off bill but have to go to Post Office regularly for pound coins. I have come from a town very similar to Droitwich and we had resident parking which was excellent - that town was Poulton-le-Fylde Lancashire. Traffic is very speedy and after 2 + years I have yet to see a policeman on foot!!

I have recently moved from Central London to Droitwich, having very regularly visited here by train for the past three years. I appreciate the breadth of topics being surveyed here.

Of note, it is very striking how car-centric such a small town is on a day to day basis. It hugely impacts on the likability of the place as well has clear tangible effects on the overall disparity between the priorities given to pedestrians, cyclists, vulnerable road users and car drivers in particular. Given the prevalence of primary schools, independent shops and percentage of residents aged over 65s is surprising that the majority of the town is not with a clearly demarcated 20mph limit once off the A38. Instead, many roads are quite wide (Saltway, B4090 and others), there are little to no convenient pedestrian crossings. A lack of calming actively encourages overspeeding throughout - if a road feels like an expressway rather than the entrance to a small town, drivers will treat it like one. It is worth noting that very few speed limit (& repeater) signs exist within and surrounding the town. In conversation, common sentiments from elderly neighbours, middle-aged acquaintances and other faces about town include the propensity of cars to be treating roads 'like racetracks' particularly around 0800-0900 and 1500-1700. Pedestrians including school children are routinely not given right of way at numerous intersections, including where very fast vehicles are attempting manoeuvres (e.g. A38-Stoke Road-Worcester Road interchange). See also attempts at walking along Kidderminster Road in the direction of Westlands or vice versa, as if certain communities are not already isolated enough. Pavement parking occurs on most residential streets, evidently causing mass damage to existing pavement infrastructure but also daily obstructions to pushchairs, cyclists avoiding cars, dog walkers and other vulnerable parties that is otherwise shrugged off. Many public residential streets are littered with boxes of metal private property that force active traffic to slalom or encourage them to drive aggressively to clear a length of uni-sided obstructions.

The large area of car parking provision around Morrisons and Waitrose provide sufficient storage for those who wish to drive into town. The lack of foot traffic by locals to the leisure centre, railway

station and other local amenities is astounding. Safe and segregated cycling lanes that are more than simply white paint do nothing to encourage healthier and more direct commuting within the town. Newer build estates including around Newland Road are a testament to induced demand - informal on-road parking dominating otherwise walkable/playable family neighbourhoods. Finally (and kudos for reading to the end of this car-edged diatribe), the failings in infrastructure are plain to see when one attempts to walk the length of the Saltway, watch an older person meander with bag of shopping to get home, or cycle to the Leisure Centre, or lock their bike securely whilst popping into town. Fundamentally, Droitwich Spa is a place built for people and has much potential to encourage the very many people who (in many other towns and cities) would be ordinarily expecting to use reliable public transport, walk/cycle to local amenities and experience their neighbourhood up close. Thank you for being part of the effort aspiring for better.

Crossings between railway station and town centre, rather than an underpass.

There ought to be a direct bus service from Droitwich to Birmingham to provide an alternative to the train. People should be discouraged from parking in residential roads close to the town centre. To this end, there should be more double yellow lines and increased parking facilities in the town centre, while encouraging people to leave their cars at home through improved public transport.

Need to reduce speeding

As soon as a vehicle gets to the top of Pulley Lane / A38 or top of Copcut Lane / A38, the traffic lights on the A38 turn to red. Make them wait longer to give the A38 traffic a better flow. VITALLY IMPORTANT.

Public transport needs to run to other local towns with a much better service. Bus services have particularly been cut in this town. Therefore we have to use our cars more frequently.

enforcement of no parking on double yellow lines. no parking at corners at road junctions

A direct bus service between Droitwich and Birmingham should be reinstated so that public transport users no longer have to rely on trains.

Community group would again monitor in conjunction with councils road-transport issues

Medical services are suffering due to housing developments. Schools and Doctors are IMPORTANT

Flooding is an issue and is likely to get worse with climate change. Do not permit development on land which has historically been a flood plain. Use of land at Chateau along the R. Salwarpe to be reinstated as a flood plain. Lighting, pavements, road maintenance, traffic calming each contribute to safe walking a cycling opportunities - they are interdependent, and improved public transport will enable many more to travel in an environmentally way.

The road design disaster at the Copcut Elm traffic lights should never have been allowed when there would have been a very good alternative route. Almost all manhole covers on the roads around Droitwich seem to have been placed where truck and car wheels need to pass over them damaging or sinking them. Who ever allows that to happen should go to Wales to see that they have very few on their roads, all being off grass verges. Cyclists have particular problems on the A38 due to the raised road surfaces by drains and very little consideration for pedestrians or cyclist paths. try walking from the station to the A442 or the A38.

Footpath maintenance can be as important as road maintenance. Some of the footpaths in Droitwich are dreadful. Made worse by pavement parking.

Tagwell Road is severely impacted by vehicles going to and from the new developments on Pulley Lane. New VAS signs have been installed but to little effect. In areas along Tagwell Road there is flash flooding and some of the houses near the Lyllelton Road junction can experience back wash from inconsiderate road users travelling too fast for the road conditions. For many years the Westlands area has been cut off with no footpaths on the Westwood Road. Pedestrians walking from the Westlands to the supermarkets off Kidderminster Road have to experience the fast ring road of Roman Way. For years this has been unacceptable and nothing has been done by WCC to address this. This area is known for deprivation and residents in social housing or home owners alike in the area are treated in an inferior manner to other areas within Droitwich. Use some of the s106 funds / CIL to improve pedestrian links from the Westlands to the town centre.

Please look at available empty structures which are eyesores before agreeing to build more empty structures. Modify/adapt what's available. There are derelict heritage buildings in this "historic" town that you refer to which is appalling. I moved here in 2017, seven years ago, and nothing has changed during this period. I have two roads which I can use when I walk into town and the trees have all been removed in both and the landscape is now completely barren on these roads. Empty shops, empty offices, empty hotels so why would you choose to build more? Putting planters, benches and trees will not attract retailers, shoppers or businesses. Poor, intermittent bus services will never encourage people to use public transport (if fares weren't heavily subsidised as they are currently it would cost £8 to travel to the nearest local towns Worcester or Bromsgrove) A railway station where the lights are turned off while evening services are still running risks people's safety, passengers & taxi drivers inc, every night of the week but local council have done nothing about this. A total void of any type of entertainment facility will never encourage new residential uptake - no cinema, no bowling alley, no dance hall, no multi-use entertainment facility, no outdoor sports facilities but be assured extra benches and planters will never help save this one horse town from dying on its backside. More needs to be done to encourage business development [I moved here in 2017 and am now moving out in November]

Victoria Square could be planted with more trees and bushes. Top priority needs to be given to the renovation of the Raven Hotel. The art dec building in the Lido complex could be developed into a Spa for massages, saunas and beauty treatments. Failing that, a restaurant overlooking the Lido pool. Lower rental charges to encourage more small businesses and shops to encourage tourism. Please please keep Droitwich train booking office open at the train station, its vitally important to have a human being to discuss train journeys with. The ticket machines are frustrating, sometimes don't work and certainly don't deal with complex journeys.

- 1. Redeveloping the Raven Hotel site would give a major boost to the town centre and rid us of the biggest eyesore.
- 2. Need some press releases/ information in the progress/ lack of progress on this site
- 3. What are the problems
- 4. Are the council taking any sort of lead/initiative to get it moving?

Having lived here for many years (1940 - how many of you have) I am sorry to say in respect of that time Droitwich is now considered a bit of a dump. Nothing here, High Street dead as a dodo, precinct nothing there worth bothering with, no classy shops now (except Humphries Shoes). Rubbish strewn in streets empty or full bottles for example. Trees are an eyesore, they need pollarding everywhere. Queen Street a mess. Telephone exchange grounds (overlooking Main entrance to Droitwich) an utter disgrace, the alley at the back of St Georges an eyesore. So very sad. Come on Councillors, get to work (never see any of you anyway - do you exist? AND YOU WANT A PAYRISE - HAHAHAH. The Raven Hotel is a disgrace to you all - you should be ashamed

Hadzor Lane forms part of a popular walk/cycle route on the East side of the town. There is a listed (grade 2) dovecote at New Court Farm which has fallen into serious disrepair due to neglect. At some future date the land may well seen as a site for housing development, in which case the dovecote would make a good focal point and design cue. (I know there have been planning applications regarding the buildings at New Farm dating back to at least 2016 but nothing comes of them!)

You must be joking! If this space was smaller I might! Oh yes! There's too many empty shops and those of goods of inferior quality. The town is short of shops like Dunelm, Next, Bon Marche etc. This would bring people in and the smaller shops of quality would also thrive. How many undertakers do we need? There's at least 3 at present. No more shops for ladies and gents clothes. Theres also 10 empty shops including 2 banks, a restaurant and we get a £1 shop!

I have seen folks crossing the A38 by the M&S Petrol Station, and it looks quite a complicated manoeuvre, specially for the elderly folks. Are they awaiting for an accident to happen before pedestrian lights are installed for crossing there! The authorities need to ass the situation beforehand.

Every time I walk along Lyttleton Avenue (I do not live there) I am saddened and appalled that the newly built houses do not, at all, blend in with existing houses. Action to stop this happening elsewhere would be a priority for me. I hope housing includes apartments - suits many. Thank you. Rather you than me! Prioritising is very difficult. Thank you for all the hard work you do. It is appreciated. Droitwich is the best place I've ever lived!

The climate crisis is real. The Town/District/County Council must understand that they cannot keep allowing the building of shoddy, poorly-insulated houses for which 2+ cars per house is a given. New housing MUST be well-insulated (solar panels mandatory) and new estates must not be allowed unless public transport connections are compulsory!

## Antisocial behaviour and intimidation

a small town which needs to pull in people to shop use cafes and experience a pleasant atmosphere would steal a real march on other towns if it offered free parking on selected central sites or money back off shopping if paying to park to stop all-day parking by workers

Droitwich's problems are the same in every town in the UK at the present time - urban decay, apathy and the progressive decline of town centres. There is a proposal to spend £20M redeveloping St Andrews Square but this is just not practical until the problem of un-used vacant retail premises is solved. My guess is that currently 50% of retail space in St Andrews Square is empty. Ok we are getting Poundland to replace Wilko and this is welcome news to fill what would be just another empty closed down shop. But Poundland isn't exactly Harrod's. This is just a never ending race to the bottom. Re-developing the canal basin is a great idea but deluding yourself that it will ever be another 'London Docklands' or 'Liverpool Waterfront' is pure fantasy. Why? Because the population just isn't proactive - there is no nightlife - no charm and no will to succeed. Now onto the Residential Development. Until all the brown field sites such as North Street etc are totally used up there should be no new build anywhere on any newly requisitioned land. Droitwich has Copcut and Pulley lane already and both were built without any additions to the infrastructure such as schools and health services. Pulley lane traffic is a nightmare, and now there is a proposal for another 400 homes on Hanbury Road on virgin agricultural land. Why don't developers such as Persimmon use brown field sites? Simple answer - they cost too much money to clean up. Its cheaper to dig up another agricultural 10 acres. Not a spade should enter the ground in Droitwich until every square meter of un-used land has been fully exploited. Severn Trent can't cope now with sewage disposal and it will take 10 years to restore these underinvested water company services to stop sewage outflow. It amazes me that sewage isn't pumped into the canal network. Sadly none of your endeavours will prevail. Objections will be upheld until the matter arrives on the desk of the Minister of Housing etc who will simply sign the proposals off as passed. This is exactly what happened in Ledbury. The whole town was eventually flooded with raw sewage. Droitwich is quite a pleasant place to live. It is clean and crime rates are low. Infrastructure and civic services can just about cope. But any more housing needs at least one extra doctors surgery and primary school. These should be built fully staffed and be fully running before any dwelling houses are built.
