5. Decisions of the Local Planning Authority:-  
 (a) Approval Notices: Wychavon District Council, the Local Planning Authority, has issued 9 approval notice since the last Town Council Planning Committee Meeting on 9 September 2024. Of these 8 did accord with the recommendations of the Town Council Planning Committee and the other had originally been a comments only consultation response [*for information*].  
 (b) Refusal Notices: Wychavon District Council, the Local Planning Authority, has issued 1 refusal notice since the last Town Council Planning Committee Meeting which took place on 9 September 2024. This decision did accord with the Town Council Planning Committee recommendations [*for information*].
6. VAS –Safer Roads Scheme. The Addyes Way Solar VAS has been repaired and reinstalled by Contractors again recently. The Salwarpe Road Solar VAS has received similar attention but is still subject to operational problems. A further approach has been made to the Manufacturer requesting return of the equipment for viability of any warranty repairs. Both signs were new replacements in May funded through OPCC grants and have been subject to further ASB damage [*for information*].
7. M5 Junctions 4 to 4A – Noise Reduction Resurfacing Works - To notify of overnight improvement works for the carriageway surface of the M5 between junctions 4 and 4A. These measures will provide smoother journeys and help reduce traffic noise for nearby residents. Scheduling is for overnight working from 10pm to 4am from Monday 30 September 2024 until Friday 11<sup>th</sup> October 2024, in the pattern of Monday to Friday working [*details attached for information*].
8. Worcestershire County Council –Emergency Notice for Bridleways. Closure Plan for Hampton Lovett – HL 537,538,539 & 540. To enable emergency repairs to footpath bridge by WCC Highways Department. Anticipated duration is 21 days from Notice Date of 12 September 2024 [*public notice and location details attached for information*].
9. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). Second Public Notice of Speed Restrictions for A38 Roman Way, Droitwich Spa. To impose a temporary 30 mph speed limit on the A38 Roman Way from the junction of A4133 High Park Roundabout for a distance of 140 metres to the A38 Westlands Roundabout, Also a temporary 50 mph speed limit from A4133 High Park Roundabout for a distance of 1475 metres northerly. To enable the installation of two Toucan crossing points over the SW approach/exit to A38 Westlands Roundabout. Anticipated duration is 102 days commencing from 2 September 2024 [*public notice and location details attached for information*].
10. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). Second Notice of Order for temporary road closure. To close a lane on the A38 Roman Way from the junction of B4065 Bromsgrove Road to its junction with A442 Roman Way, Westlands Roundabout in a westerly direction only .To enable carriageway resurfacing by WCC Highways Department. Anticipated duration is 2 nights (working 20.00 to 06.00) between 19 September and 2 October 2024 [*public notice and location details attached for information*].

11. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). First & Second Notices of Order for temporary road closure for A38 Westlands Roundabout Droitwich Spa. To close the section of the C255 Kidderminster Road from the junction of A38 Westlands Roundabout as far as the junction of U41771 George Baylis Road. To enable kerb line adjustments in preparation for installing the Toucan crossings by WCC Highways Department. Anticipated duration is 14 days (working 24 hours for weekdays only) commencing 3 October 2024 *[public notice and location details attached for information]*.
12. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). Second Notice of Order for temporary road closure for U41701 Kidderminster Road, Droitwich Spa. To close the section of U41701 Kidderminster Road from the junction of C2255 Kidderminster Road Roundabout to the junction of U41701 Vines Lane. To enable bridge repair work by XEIAD. Anticipated duration is 1 day from 26 September 2024 *[public notice and location details attached for information]*.
13. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). Permitted Parking Area and Special Parking Area, Waiting Restrictions and Street Parking Places – Consolidation Order 2004- Variation Order 2024. Prohibition of Waiting at any time on Blackfriars Avenue. Droitwich Spa. To apply for the section from a point 10 metres north east of the junction of Old Coach Road for a distance of 18 metres north easterly. The order becomes operational on 26 September 2024 *[public notice, location and sealed order details attached for information]*.
14. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). First Notice of Order for Temporary Footpath Closure. For the Link Footpath F40110 between property numbers 22 & 24 at Ledwych Gardens, Droitwich Spa. To enable footway reconstruction by WCC Highways Department. Anticipated timescale is 5 days commencing 28 October 2024 *[public notice and location details attached for information]*.
15. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). First Notice of Order for Temporary Footpath Closure. For the Link Footpath F40956 Cherry Close, Droitwich Spa to the junction of U41500 Cockshute Hill. To enable footway reconstruction by WCC Highways Department. Anticipated timescale is 5 days commencing 7 October 2024 *[public notice and location details attached for information]*.
16. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). First Notice of Order for Temporary Footpath Closure. For the Link Footpath F40208 Chawson Pleck to Middle School, Droitwich Spa. To enable bridge repair works by WCC Highways Department. Anticipated timescale is 5 days (24 hours closure) commencing 28 October 2024 *[public notice and location details attached for information]*.
17. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). Second Notice of Order to impose a temporary 50 MPH speed limit on that part of A38 Roman Way ( Westbound only) from its junction with B4065 Bromsgrove Road. For the reason to install 2 Toucan Crossings over the SW approach/exit to A38 Westlands Roundabout. Anticipated duration is 71 days from 3 October 2024 *[public notice and location details attached for information]*.
18. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). Second Notice of Order for Temporary Road Closure of A38 Roman Way, Droitwich

Spa. To close the section from the junction of the A38 Westlands Roundabout (south bound only) to the junction of A4133 High Park Roundabout. To plane and pave the carriageway surface as part of the installation of Toucan crossing points. Anticipated duration is 17 nights (working 20.00 to 06.00) commencing 16 September 2024 [*draft order, public notice and location details attached for information*].

19. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). Second Notice of Order for Temporary Road Closure of part of the C2255 Kidderminster Road, Droitwich SPA from the junction of A38 Westlands Roundabout to the junction of U41771 George Bayliss Road. To enable kerb line adjustments as part of the preparations for the installation of Toucan crossing points. Anticipated duration is 14 days (24 hours weekdays only) commencing 3 October 2024 [*public notice and location details attached for information*].

20. Worcestershire County Council – Road Traffic Regulation Act 1984 (as amended). First Notice of Order for Temporary Road Closure of A38 Roman Way, Droitwich Spa. To close the section from the right hand flier lane on to the B4065 Bromsgrove Road for a distance of 82 metres in an easterly direction. To enable the installation of sign and posts in the central reservation by WCC Highways Department. Anticipated duration is 1 day commencing 4 November 2024 [*public notice and location details attached for information*].
